
"Sir, MC Singla case is listed at Sr. No. 17 item 117 in Court no.2. The list will be heard on 10th December 25 and if all the matters in list of 10.12.25 are not heard on that day the remaining matters of 10.12.25 list will be heard on 11th December 2025. So, we hope that our matter may come up for hearing on 10th or 11th December 25. I have discussed the matter with Mr. Sunny Chaudhary counsel for PNB officers/ petitioners and I alongwith Shri J D Sharma Sir.... will have a meeting with him tomorrow 6.12.25 to finalise strategy and compilation of documents to be handed over to court at the time of hearing.
