Sub: (1) The programme of Dharna scheduled on 22nd February,2024 stands cancelled under compelling circumstances as Police Authorities Declined Permission.

- (2) The Programme of the meeting of the Governing Council stands as per schedule.
- (3) The programme of the meeting of the Constituents of CBPRO stands as per schedule.
- 1. Due to the prevailing situation arising out of the on- going Kisan movement and invocation of Section 144 of IPC in the entire national capital, the Police authorities have informed us that they had withdrawn the permission given to the CBPRO/AIBPARC Dharna scheduled to be held at Jantar Mantar, Delhi on 22nd February, 2024. We convey our sincere regrets to inform the members that the programme of Dharna stands cancelled. We highly appreciate the enthusiasm displayed by the Bank Pensioners and Retirees all over the country and assure them that the struggle will be carried forward with all sincerity, confidence and conviction.
- 2. The meeting of the Governing Council will take place on both the days of 21st& 22nd February, 2024. The meeting of the 1st day will start at 10 am and conclude at 5 pm. The meeting of the second day will start at 10 am instead of 2 pm as communicated earlier because of the cancellation of the programme of Dharna.
- 3. The meeting of the constituents of CBPRO will take place on the scheduled date and time i.e. 5 pm of 21st February, 2024.
