

As already informed on 8.4.26 the 3 judges bench will sit in Court no.2 and if the 5 matters earmarked for 3 judges bench are disposed on 8.4.26, then on 9.4.26 the two judges branch may sit and MC Singla case which may be 3rd in the regular list may come up for hearing.”
