### **1.Struggle against privatization:**

In the event of Government announcing any measure to privatise the Banks, the same should be protested through strike actions for which membership should be kept prepared.

### **2.Improvement in Family Pension and Contribution of NPS :**

Thanks were conveyed to Union Finance Minister and Government for final clearance of the proposals which paved the way for implementation.
