**Dear Friends and Comrades,**

**Sub: All India agitation call given by CBPRO – vide circular 06 – 2025 dated 18.06.2025**

1. Members all over the country are aware of the fact that a programme of Day Long Hunger Strike and Dharna culminating in general meetings in all state capitals or in any other place of the state as decided by the respective state committees on 31<sup>st</sup> July, 2025 or any other convenient date depending upon the availability of Police permission and climatic conditions was declared by CBPRO.

2. We have noted with pleasure and satisfaction that the response from the state committees, the constituents of CBPRO and above all the members have been stupendous and unthinkable. There have been similar such programmes in past also but this time it has been something spectacular. The glorious differences from previous programmes which have been observed are as under:

(A) Till today, there have been more than 20 places where the programme has been organized. As per information available, the Day Long Hunger Strike will take place in some more places in the next week. In other words, at the call of CBPRO, 22 places have already witnessed and also will witness the gathering of Senior and Super Senior Citizens with commitment and dedication to the cause. This has been definitely a forward development over the coverage of agitation in the past. We salute the initiative of the constituents of CBPRO and their state organizations.

(B) The number of participants taking part in the agitation has been encouragingly high. Age and ailments did not speak the last word. The tremendous desire from the inner soul brought the Senior Citizens out in the streets and they did it from the call of their hearts. We have truthfully reported the numbers in each circular. It will be seen that in several places, the attendance was above 1000 and in certain cases, it was nearly 1000. Notwithstanding different restrictions of the Administration on the Hunger Strike by senior citizens, the people and the organizations did their best. We salute their zeal and firm determination to fight against Injustice and gross Discrimination.

(C) It has been really encouraging to note that the agitation programme of CBPRO has got extensive coverage of the Print and the Electronic Media. The social sites like YouTube and Facebook have not lagged behind. The message of the organization has reached the Society and the Nation through such medium of communication. In

(E) We convey our sincerest Thanks, Admiration and Gratitude to all our valiant Comrades and Constituents of CBPRO for making such a massive response to the call of the organization. The outcome of the agitation will be further reviewed by the leadership and necessary communications will follow. However, it is necessary to be in readiness to go for a very Massive and Record making Program at Jantar Mantar, New Delhi on a date to be decided in consultation with all the Constituents. We are confident that all Bank Pensioners and Retirees and their Organisations will join the Struggle to espouse the Common Cause of ensuring Justice to all of us. **Let us come together. Let us script a Great Success Story before it is too late.**
